1 Who we are

FWH Creations is a small charity which is supporting and developing an ethically based tailoring project in India (jacobswell) designed to deliver vocational training and employment particularly to vulnerable women. jacobswell, is a member of the WFTO, producing Fair Trade Fashion products for clients around the world, FWH Creations is providing training and management expertise to grow jacobswell and to equip, train, educate (and provide accommodation where applicable) both the employees of jacobswell and other vulnerable people with skills to enhance their prospects. It is funded by donations from supporters such as individuals, groups and companies and some of these donations are gift aided. Some of the funding is through agencies such as the Charities Aid Foundation and Virgin Giving. It also provides newsletters to people who have expressed interest in the charity.

5 Secure Storage and Transfer of Data Within the Charity

Hard copies of the signed gift aid forms will be kept in a locked cabinet in a secure building. Hard copies of bank account details will also be kept in the same locked cabinet until the first payment have been received.

All sources of data will be stored in encrypted, password protected files and periodically backed up to an alternative secure location on an encrypted cloud based solution.

Personal data will only be shared with other trustees when required for a specific task and

limited to the data required to perform that task. Emails to the charities supporters should be sent BCC so that members are not given unnecessary, unconsented access to other supporters' email addresses.

6 Data Retention - How long will we keep your data for?

For financial supporters we will hold your data on our records for six years from your last gift declared on the declaration. For other supporters, we will revalidate consent every four years.

7 Your right to access your data

If you would like to see a copy of the personal data that we hold on you, please contact admin@fwhcreations.biz In compliance with the General Data Protection Regulation we will need the request to be provided in writing and to see photographic Identity and proof of address in order to confirm your identity before we can share the data with you.

9 Deleting your data
